25.2.7 COMPETITON RULES

The results for the 1440 Round (for recurve) and Double 30/50 Meters (for compound) will be used as the basis for ranking the individual competitors in the Girls and Boys Divisions. Based on their ranks, the archers will then



proceed to the Olympic Round to determine the Overall Individual Champions for Girls and Boys Divisions.

25.2.7.1 Competition in the Olympic Round will be as follows:

- 25.2.7.1.1 An Elimination round in which the top 16 archers (seed according to their rank in the 1440 Round/Double 50) in each category shoot a series of matches to determine the quarterfinalists. Each match shall consist of five (5) sets of three (3) arrows shot at the 122 cm target face (recurve division) and cumulative scoring (compound division) with an 80 cm 6 ring placed at the following distances:
- 25.2.7.1.2 A Finals round in which the remaining quarterfinalists (top 8 archers in each class) shoot a series of matches, ending with the Gold Medal Matches. Each match shall consist of up to five (5) sets of three (3) arrows shot at 122 cm and 8- cm 6-ring target face placed at the following distances:

25.2.7.2 Team Competition

- The scores in the 1440 Round of the <u>three (3) archers</u> from each team/LGU shall be their aggregate score. All Team/LGU scores will be calculated similarly and each Team/LGU will be ranked from 1 to 8 in the Girls and Boys Classes. However, any member of a team who shot in the Qualification Round may be fielded in the Team Event provided the final composition must be submitted to the tournament secretary one (1) hour before the start of the match. All teams will shoot in the Olympic Round Team Event which consists of:
- The **Team Finals Round** is in which the top eight (8) teams in each category shoot a series of matches ending with the Team Gold Medal Matches. Each match shall consist of four (4) ends of six (6) arrows shot at 122cm (recurve) and 80 cm 6-ring (compound) target face placed at the following distances:

25.2.7.2.3 The scores in the 1440 Round of the top-ranked boy archer and top-ranked girl archer from the same team/LGU shall be their MIXED TEAM's aggregate score. Ch All Mixed Team scores will be calculated similarly and each LGU Mixed Team will be ranked from 1 to 8. All teams will shoot in the Olympic Round Mixed Team Event which consists of:

25.2.7.3 Timing Control

Timing equipment with Visual and Audio will be used.

25.2.7.4 Result System

- 25.2.7.4.1 Qualification Round scoring will be done by archers. One archer record, on the official scorecard, the scores of all other archers on that target. At the same time, another archer on the same target will enter all the scores of the archers on that target into the scoring tablet. The other archer should verify that all scores are written and entered correctly.
- 25.2.7.4.2 Scorecards MUST be signed by the archer and have the full total completed; in case of non-conformity, the archer will be Disqualified (DSQ).
- 25.2.7.4.3 Scorecards with the 10's + X's and X count NOT COMPLETED WILL BE COUNTED AND SCORED AS ZERO "0".
- 25.2.7.4.4 Elimination Round scoring will be done by archers. One archer/ Team records the arrows values of both archers/ team on the paper scorecard. While at the same time, the other archer/team witnesses the inputs the arrow values, the other archer will call the arrow of each archer (one at a time). Archers/ Teams should verify that all scores are written and entered correctly before returning to the shooting line.



25.2.7.4.5 At the end of the match, the scorecard must be fully completed and signed by the archers involved in the match, otherwise, the concerned archer(s) will be Disqualified (DSQ).

25.2.10 SOLIDARITY MEETING

A team captain's meeting will be held during the Solidarity session to discuss the schedule, uniform requirements, latest rules or rule modifications, medals to be awarded, and other important matters. Coaches who did not attend the solidarity meeting waive his/her right to protest.



25.2.11 PROTESTS AND APPEALS

25.2.11.1 Jury of Appeal

The jury of appeal shall be comprised of one (1) Chairman and two (2) members from the judge's commission. The Technical Delegates will act as its chairman. The decision of the jury of appeal shall be final.

25.2.11.2 Appeals

- 25.2.11.2.1 In the event of an athlete not being satisfied with a ruling given by the judges; he may except provide for article 17.1. above, appeal to the jury of appeal according to 3.13. Jury of appeal in book 2. Trophies or prizes which may be affected by a dispute shall not be awarded until the jury ruling has been given.
- 25.2.11.2.2 The decision by the judges on the value of an arrow before the withdrawal from the target but face is final.
- **25.2.11.2.3** The decision made by the judge in the team event round concerning the use of the yellow card signals the violation described in Article 15.3 is final.
- **25.2.11.2.4** The decision of the jury is final, and it cannot be appealed.
- 25.2.11.2.5 An appeal form is attached to this document (see attached after this chapter, appendix 1).
- 25.2.11.2.6 Appeal form should be given or an actual appeal, the times indicated on the appeal form must be considered.
- 25.2.11.2.7 A fee of P10,000.00 must be paid to the chairman of the Tournament Judge Commission or their deputy.
- 25.2.11.2.8 If the appeal is upheld by the jury of appeal, the fee will be returned, In the case of appeal being rejected, the fee will not be returned.

25.2.12 EQUIPMENT AND CLOTHING

25.2.12.1 Clothing

- 25.2.12.1.1 All members of the team, including the coaches, must wear the same uniform during the Team Event.
- The archer's family name followed by the initials of his first name (e.g. DELA CRUZ, A.), should be printed on the upper back portion of the shirt. Letter height is from 5cm. in block letters. All shirts worn during the tournament must bear the archer's name as described above. Aside from the official delegation uniform, a team may wear an alternate uniform which should also have the archer's names printed on the back. All archers must wear rubber shoes. Slippers, Crocs, sandals, and similar footwear shall not be allowed.
- 25.2.12.1.3 Rubber boots and rain gear may be allowed if the weather and field conditions warrant their use.
- 25.2.12.1.4 Archers must always wear their target assignment numbers on their arrow quivers when shooting in the tournament, during the official practice day, and during the official inspection of equipment. Numbers must be properly pinned on the archers' quivers.
- **25.2.12.1.5** Team uniforms are required to be worn during the official practice day.



25.2.12.2 Equipment

Each archer should have his/her own set of equipment which should conform to WA Recurve Bow specifications. It is the archer's responsibility to use equipment that complies with the rules. If in doubt, the archer should show his equipment to the Judge(s) before using it in competitions.

An initial inspection of the archer's equipment will be conducted by the Judges' Committee during the Official Practice Day. However, subsequent inspections may be done during the tournament to ensure adherence to equipment rules, if these will not affect the settings of the bow in question. Later violations, when found, will be penalized according to WA rules.

Note: The maximum weight for 12 years old compound bow is 20lbs.
