##### 25.27.4.2.1.1 Youth competitors shall be between 15 and 17 (including 17) years of age;

## 25.27.7 COMPETITION RULES AND REGULATIONS

### 25.27.7.1 Taolu

**25.27.7.1.1** The competition will utilize the Non-Degree of Difficulty Scoring Method (comprising A Group – Quality of Movements Scoring and B Group – Overall Performance Scoring only).

**25.27.7.1.2** Time Limit:

**25.27.7.1.2.1** Group A and B (Changquan, Daoshu, Jianshu, Gunshu, Qiangshu, Nanquan, Nandao and Nangun) no less than 1 minute 20 seconds.

**25.27.7.1.2.2** Taijiquan, Taijijian is 3 minutes to 4 minutes

**25.27.7.1.2.3** There is no time requirement for Elementary Taolu events.

### 25.27.7.2 Sanda

**25.27.7.2.1** If the number of competitors in a weight category is three (3) persons, a single round-robin method will be adopted.

**25.27.7.2.2** If only two or one athlete(s) registered in a weight category, the weight category will be cancelled.

**25.27.7.2.3** Kicks to the head are prohibited.

**25.27.7.3** Weigh In Competitors will be disqualified if their weighing results do not meet the requirements of their reported weight class.

### 25.27.7.4 Rules and Regulations

**25.27.7.4.1** Each team must strictly abide by the rules and regulations of the competition and compete fairly.

**25.27.7.4.2** Those who violate the regulations will be dealt with severely in accordance with the relevant regulations of the Wushu Federation of Philippines

**25.27.7.4.3** Each team must bring and submit the following items and information when reporting:

**25.27.7.4.3.1** Copy of PSA Birth Certificate

**25.27.7.4.3.2** Parent consent

**25.27.7.4.3.3** Signed Waiver of Liability (*to be shown at the end of this sports guidelines*)

**25.27.7.4.3.4** One final registration form

*NOTE: Copy of Parent Consent, Waiver of Liabilities should be given at WFP representative during registration, before the official weigh in and draw lots.*

**25.27.7.4.4** During a bout, the coach may only be accompanied by one assistant coach or team doctor. They must wear official attire and must remain seated at the designated spot (shorts and sandals are not allowed).

**25.27.7.4.5** Using LINIMENTS and the like **will be disqualified** from the game.

## 25.27.8 COMPETITION FORMAT

### 25.27.8.1 Placing & Awards

**25.27.8.1.1** Taolu

**25.27.8.1.1.1** 1st Place - Gold Medal and Certificate

**25.27.8.1.1.2** 2nd Place - Silver Medal and Certificate

- 25.27.8.1.2.3** 3rd Place (juxtaposition) - Bronze Medal and Certificate

## **25.27.8.2 Victory Ceremony**

- 25.27.8.2.1** The medalists are required to attend the Victory Ceremony.
- 25.27.8.2.2** The medalists must report to the designated place fifteen (15) minutes before the Victory Ceremony starts, and must wear their team official uniforms.
- 25.27.8.2.3** The medalists are not allowed to wear one-piece suits, gloves, hats, goggles, sunglasses, etc. to attend the award ceremony, and are not allowed to take any religious symbols to or onto the podium.
- 25.27.8.2.4** The medalists who are absent from the Victory ceremony without a valid reason will forfeit the right to receive a medal.
- 25.27.8.2.5** If fewer than three (3) medalists in a single event, no Victory Ceremony will be held for that event. The team leader will go to the designated place to receive a medal and certificate.

## **25.27.9 ENTRIES**

Participation is exclusively through accreditation by a Local Government Unit (LGU), which can be at the provincial, city, or municipal level. No athlete will be accepted without proper accreditation from a specific LGU. Each athlete is allowed to represent only one (1) LGU.

### **25.27.9.1 Requirement**

- 25.27.9.1.1** **Taolu**
- 25.27.9.1.1.1** Each team or Local Government Unit may enter a maximum of TWO participants per event.
- 25.27.9.1.1.2** Each athlete may enter a maximum of three events: one barehand, one short weapon, and one long weapon.
- 25.27.9.1.2** **Sanda**
- 25.27.9.1.2.1** Each team or Local Government Unit may sign-up one (1) competitor for each weight category, and each competitor is allowed to apply for only one (1) weight category.

### **25.27.9.2 Registration**

- 25.27.9.2.1** Entries with the events and names of competitors must reach the Philippines Sports Commission via courier by 08 August 2025.
- 25.27.9.2.2** Log in at <https://batangpinoy.psc.gov.ph> for more details.
- 25.27.9.2.3** Designated billeting will be advised as soon as possible by the Philippine Sports Commission.
- 25.27.9.2.4** Teams that wish to stay outside the provided billeting by the Philippine Sports Commission will be responsible for their own expenses.

### **25.27.10.1 Technical Matters**

- 25.27.10.1.1** Each team may send representatives to attend the meeting during which matters concerning the competitions will be announced.

## 25.27.12 EQUIPMENT AND CLOTHING/UNIFORM

### 25.27.12.1 Taolu

- 25.27.12.1.1 Costumes worn and equipment used by competitors must comply with the rules during all events.
- 25.27.12.1.2 Competitors must prepare their own costumes and equipment.

### 25.27.12.2 Sanda

- 25.27.12.2.1 IWUF approved clothing for men includes sanda shorts and vest, and for women includes sanda shorts (skirt) and t-shirt. The shorts (skirt) and vest will be of the same color, namely red or blue. Competitors are required to provide their own clothing, and this should include one (1) set in red and one (1) set in blue. (Fig. 1 & 2)
- 25.27.12.2.2 Protective gear is separated into two colors, namely red and blue. Protective gear includes headgear, gloves, chest protector, shin guard (applicable for Children and Junior competitions), instep guard (applicable for Children, Junior and Youth competitions).
- 25.27.12.2.3 Competitors are required to provide their own gum guard, groin cups and hand wraps. The groin cups must be worn under the trunks. The length for hand wraps shall be between 3.5 m and 4.5 m in total. (Fig 1 & 2)
- 25.27.12.2.4 For female competitors who are of the Islamic faith, the IWUF has permitted such competitors to wear Islamic competition attire in line with the below standards. Such competitors are required to wear all the below stipulated Islamic attire and may not selectively wear some of them separately. This includes the following: (Fig 3 & 4)

### 25.27.12.3 Competition Attire

- 25.27.12.3.1 Strictly follow IWUF competition attire color code (RED, BLUE).
- 25.27.12.3.2 Competition attire with LGU logo or Regional name will be allowed.
- 25.27.12.3.3 Wearing other sports competition attire will be disqualified from the Game.

### 25.27.12.4 Protective Gear



- 25.27.12.4.1** Competitors are required to provide their own gum guard, groin cups, hand wraps, foot pads and shin guards.
- 25.27.12.4.2** The groin cups must be worn under the trunks. The length for hand wraps shall be between 3.5 m and 4.5 m in total. (Fig 1&2)
