25.10.6 ELIGIBILITY

25.10.6.1 The Cycling events are open to Riders/Cyclists representing their respective Local Government Units (LGUs - city or province).

- **25.10.6.2** The age of athletes shall not be older than 17 years old and not younger than 12 years old.
- **25.10.6.3** LGUs shall register their athletes only through a PSC-designated portal.

25.10.7 COMPETITION RULES AND REGULATIONS

25.10.7.1 Responsibilities

- **25.10.7.1.1** The ICFP/PhilCycling shall not, under any circumstances, be liable to any accidents or damages that occur during training and competitions.
- **25.10.7.1.2** For all cases not covered by these specific regulations, the UCI rules will apply.

25.10.7.2 Anti-Doping

Anti-doping controls according to the regulations of the UCI will be announced.

25.10.7.3 Penalties

Penalties shall be applied in accordance with the UCI regulations.

25.10.7.4 Waste Disposal

Empty bottles, peels or any form of trash shall be disposed of properly. Violators will be penalized accordingly.

25.10.8 COMPETITION FORMAT

25.10.8.1 Awards Ceremonies

- **25.10.8.1.1** The 1st, 2nd and 3rd placers shall be awarded the gold, silver and bronze medals.
- 25.10.8.1.2 The awarding ceremonies shall take place no more than 30 minutes after the Official Result for each category/event was signed by the Chief Judge.
- 25.10.8.1.3 The Top 3 placers shall make themselves immediately available for the Medal Ceremony and shall wear their complete jerseys.
- **25.10.8.1.4** All riders/cyclists specially the Top 3 placers in all events and categories shall make themselves available for media interviews.

25.10.9 NUMBER OF ENTRIES (Per Event)

- **25.10.9.1** An LGU may enter a maximum of two (2) athletes per event.
- **25.10.9.2** An athlete may participate in a maximum of two (2) events only.

25.10.10 TEAM LEADERS' MEETING AND DRAWS

Team manager's meeting will be held on 25 October 2025.

25.10.11 PROTESTS AND APPEALS

25.10.11.1 The decision of the Commissaires Panel and/or Jury are final. Protests shall be filed in accordance to regulations set forth by the Batang Pinoy-Philippine Sports Commission.



25.10.12 EQUIPMENT AND CLOTHING/UNIFORM

25.10.12.1 Bicycles and Equipment Control

25.10.12.1.1 Standard bicycles shall be allowed in all disciplines of Road, MTB and BMX.

25.10.12.1.2 International Cycling Union Regulations (UCI) shall apply in this article.

25.10.12.2 Clothing

25.10.12.2.1 Clothing shall only be UCI-regulation—jerseys, shorts and socks (must not exceed the halfway mark between the edge of the angles and the bottom of the knees).

Regulation helmets are mandatory. Unauthorized clothing or apparel is forbidden.
