#### 25,20,7 COMPETITION RULES AND REGULATIONS

The competition management approved this Sepak takraw Technical Handbook whereby the conduct of Sepak takraw shall be in accordance with the currently enforced 2024 ISTAF Law of Sepak takraw, in effect starting 01 February 2024.

## 25.20.7.1 Consequences of Walkover and Abandonment

Any team that concedes a walkover or causes a match to be abandoned shall be considered to have lost the particular match and a score of two (2) sets to zero (0) sets regardless of the number of sets having been played already in the match.

A team who has already earned a Medal prior to the semi-final stage but concedes a walkover or abandons its succeeding match, semi-final or final, shall forfeit its right to any Medal.

In such circumstances, the medal shall be awarded to the next higher ranked team from the non-qualifiers of the semi-final based on the (a) number of matches played and won, (b) number of sets won, and (c) aggregate scores whether they won or not from All its matches.

For the purposes of ranking and reporting by the competition management, the team responsible for the walkover or abandonment shall be placed at the bottom of the rankings.

## 25.20.7.2 Reporting Time of Teams and Technical Officials

- **25.20.7.2.1** Technical Officials and Referees should arrive at the field of play (FOP) one hour and thirty minutes before the posted time of the match.
- 25.20.7.2.2 All teams should arrive at the field of play (FOP) one hour before the posted time of their match.

Each match will require to start at a specific time, where it shall be interpreted as the Referee already calling the score "love all" where the clock strikes at that hour/time. The fifteen (15) minutes allowance - before a walkover/default shall be declared - starts from the posted time of the match of the involved team.

## 25.20.7.3 Doping Control

The Sepak takraw Management Team shall abide with the rules that will be imposed by the PSC National Organizing Committee about the conduct of doping, if any, among the athletes of Sepak takraw along the rules of the World Anti-Doping Agency or WADA.

## 25.20.7.4 Penalties in Case of Fraud by the Team

The Sepaktakraw Management Team upon receipt of any Incident Report by its Technical Officials of Sepaktakraw shall initiate a thorough investigation and following due process shall endorse an imposition of reasonable penalties for the specific weight of offense done by the team, specifically for its Team Manager, Coach and/or Players to the PSC National Organizing Committee, for their discretion.

The offense here includes Sepaktakraw alone as mentioned in Rules 15, 16 & 17 of the 2017 Law of the Game of Sepaktakraw. Violation of provisions in this 2025 Sports Management Technical Handbook for Sepaktakraw is also included.

#### 25.20.7.5 Media Interview

No Technical Official shall be allowed to give statements in any form to the Press or Media without the consent of the Tournament Director upon consultation with the 2025 Philippine BP Games National Organizing Committee. Reasonable Penalties shall be imposed given a violation.

#### 25.20.8 COMPETITION FORMAT

## 25.20.8.1 Mode of Competition

25.20.8.1.1 Best Regu Event (Code: BR)

The tournament shall be played in Single Round Robin System grouped and bracket system, number of brackets will depend on numbers of participants: sample Bracket 4, 8 or 16 would be implemented in case of more Participants are participated.

Sample: Bracket A, B, C and D for the elimination round. The top two (2) teams in each group will advance to the crossover quarterfinals using the knockout system, losers in the schedule first game will receive 16 - 8 placer and so on

There will be quarterfinals, semi-finals and finals in this match. The winner in each group shall play with the first runner-up

# 25.20.8.2 Determining the Point System Scheme

Two (2) points shall be awarded for the win and zero (0) for a loss.

If two (2) or more teams obtain an equal number of points

If a tie still exists, "win-over-the-other" WILL NOT BE APPLIED, instead all points during their "game between each other" will be computed highest points prevail.



If three teams are tied with the same preliminary standing breaking the ties shall be broken in the following order:

25.20.8.2.1	sets won,
25.20.8.2.2	sets loss,
25.20.8.2.3	net sets won, (biggest number wins)
25.20.8.2.4	total points earned when the team won,
25.20.8.2.5	total points earned when the team lost,
25.20.8.2.6	net points by deducting item (6) from item (5), the lower the number here, the better the team (if a negative net point is achieved, team is in bad position,
25.20.8.2.7	net points of each match, if a match is won, points is positive but if lost, it is negative, where all positive and negative are computed, the higher the positive
	number, the better is the team,
25.20.8.2.8	net points per set using item (4) as a numerator and getting the total number of sets played whether the team won or not, the higher the number here, the better is
	the team,
25.20.8.2.9	total points earned.

**ALL MATCHED** played by the teams shall be used in computation to break ties.

## 25.20.8.3 Victory Ceremony

The schedule of the Victory Ceremony will immediately after the Final Match, however, if PSC BP 2024 Games' National Organizing Committee has already scheduled a program, the Sepak takraw Management Team shall recognize and follow it.

Note: DOUBLE BRONZE WILL BE APPLIED.

## **25.20.9** NUMBER OF ENTRIES (Per Event)

Entries of each Local Government Unit must be submitted according to the regulations imposed by the Organizing Committee of the Philippine National Games and Batang Pinoy Rules indicated in BP Form B.

Note: Only entries downloaded by Philippine Sports Commission (PSC) WILL ONLY BE ACCOMMODATED.

#### 25.20.10 TEAM LEADERS' MEETING AND DRAWS

The Team Managers' Meeting & Technical Officials/Referee Refresher Meeting shall be held on October 26, 2025, the venue of which will be at the Field of Play (FOP) location.

#### **25.20.11 PROTESTS AND APPEALS**

All entries are presumed to have been decided with finality by the National Screening Committee, therefore, any protest on eligibility shall not be entertained by the Sepak takraw Competition Management Team.

All matters arising from the actual conduct of the match that will push teams to file a protest shall require its filing within one hour after of the posted match schedule and a Bond determined by the PSC National Organizing Committee or if none an amount of P5,000 payable to PSC National Organizing Committee that is refundable only if the decision of the Jury and/or Appeals Committee favors the protesting team. If otherwise, there will be no refund.

### **25.20.12 EQUIPMENT AND CLOTHING/UNIFORM**

All the equipment shall be in accordance to the recognized official ball and net of Sepaktakraw by the Pilipinas Sepak takraw Association.
